NOTIFICATION

No. ASSEB/DIV-II/EXB/MISC/2018/63(II)/452. : It is for information to all concerned that the matter of holding of examination of remaining subjects of HS First Year, 2025, the Board again discussed the matter in the Board's meeting held on 04.04.2025 with reference to the Board's notification vide no ASSEB/DIV-II/EXB/MISC/2018/63(II)/439 dated: 25.03.2025 and decided as follows:

- 1. Consequent upon declaration of the dates of Panchayat Election, it is obvious that the Teachers community of the state shall be engaged in preparatory works of the Election, training of polling/counting staff, conduct of Election and counting of votes etc. As per the schedule announced by the State Election Commission the Election process may continue up to 20th May, 2025.
- 2. In this scenario, it will be very difficult for the institutions to hold the Examinations before completion of Election process and in conducting remaining examinations after election process will be too late

Hence the Board decided to cancel the examination of the remaining subjects of HS First Year Examinations, 2025.

However, the following procedures will be adopted to complete the examination process.

- 1. All the students who have appeared in the examination of the subjects held in the month of March,2025 will be allowed to appear in the H S Final Examination,2026.
- 2. The Class XI examination is basically a school examination. Until 8 years back, the institutions were conducting the annual examination of class XI on their own. But, it was observed that the standard of Question set by the institution and inclusion of topics in the Question papers were not uniform. In view of the above since last 8 years Board has been providing Question Papers to maintain a standard pattern as well as to acquaint the students themselves with the standard of H S Final Examination and also for self-appraisal. However, the examination was conducted like a school exam only without any restrictions.
- 3. Therefore, in order to maintain the above objective, if Institutions or students want to analyze themselves regarding performances of the remaining subjects they

may collect the question papers from their respective lead college for study and practice.

However, the institutions against whom investigation is going on for breaking of seal of Question Paper packets before scheduled date and time, are not allowed to collect any packets of Question Papers from the lead college for study and practice.

4. As regards the issue of marks sheet to students for the Annual Examination of Class XI of this year, the respective Institutions will be authorized to download marks sheet from the website of ASSEB, Div.-II, which will be notified in due course of time. In such cases marks against the subjects for which examination is not conducted are to be provided on the basis of performance of the student in the unit test/half yearly examination or average marks obtained by the candidates in the subjects for which examinations were held as per schedule or any other suitable method.

The process of uploading of marks should be completed by 15th June, 2025.
